Any person aggrieved by the Open Space, Sport and Recreation Supplementary Planning Document may make an application to the High Court under Section 113 of the Planning and Compulsory Purchase Act 2004 on the ground that either the document is not within the power conferred by Part 2 of the Act or that a procedural requirement of the Act or its associated Regulations has not been complied with. Any application must be made no later than 6 weeks after the date of the Adoption specified above.

In addition, any person aggrieved by the Open Space, Sport and Recreation SPD may apply to the High Court for permission to apply for judicial review of the decision to adopt the statement, and any such application must be made no later than 3 months after the date of adoption as specified above.
