HS2 Justification ---- Strong Objection

I wish to add my objection comments to the Local Plan in proposing to build on Parndon Wood Area (as stated and shown in my attached photos).

- 1. I have been told this is Green Belt and should not be built on.**
- 2. If its not Green Belt it is certainly classed as Green Area as shown on the photos and must not be built on and protected.**
- 3. The area you intend to build on, immediately faces my house which I purchased a short while back for its views over the Green Area and over the small road with wonderful trees. Your plan will destroy this and devalue my house.**
- 4. The road as you will see is extremely busy providing entrance to the Crematorium and Parndon Wood Wildlife Area. Many people park in this road to use the Christian Centre at all times and also when visiting the Parndon Wood Wildlife Area. As you will see the road is only wide enough for one vehicle in each direction and therefore when parking all the way up this road it becomes a one way road only. It does not have any paths and many people including young children visit the wildlife area to watch and learn about where they live.**
- 5. Do not think about widening this road as it would make the area even more unsafe for Wildlife of which there is a large amount in front of my house and all over the Green Area right up to the Crematorium and joining the Wildlife Area itself. The trees and vegetation all the way up have a huge amount of wildlife. If you make the road bigger vehicles will speed up and make it very dangerous for our children even if there is a path.**
- 6. The Crematorium is an extremely important Burial Ground and is very quite and peaceful and must be kept as it is with NO NOISE or INTERRUPTION at any time . Do not destroy this very important area as building will.**
- 7. Likewise the Parndon Wood Wildlife area is very peaceful and quite for children and adults who care very much for all the interesting wildlife in there and all the way up to it. Many professional photographers also**

use the area and hides to take superb photos of all their interest. Local schools also use the area to learn and understand what we live with and need to protect for the rest of our lives.

8. Many children from this area and specially Fennals use the green area as a way to and from school and you would force them to go all round by the roads and risk their lives with the speeding vehicles.
9. HOW MANY WILL SUFFER BECAUSE OF YOUR PLAN CONTAINED IN HS2.
