### Suitability criteria

Section 6 of Schedule 4 gives the reasons for refusal of a licence. One reason, (d), is that the applicant is unsuitable to hold the licence by reason of having been convicted of an offence or for any other reason.

The council will not grant a licence to anyone unless it is satisfied that they are a suitable applicant. The council will consider the following criteria when assessing the suitability of an applicant:

- the integrity of the applicant
- the competence of the applicant to undertake street trading in a manner consistent with the street trading policy
- any previous criminal history or pattern of behaviour

The Rehabilitation of Offenders Act 1974 applies to persons who wish to apply for a licence. This means that convictions (not all) and cautions become spent in accordance with the provisions of the act.

The council will not grant a licence to an applicant who has been convicted of a specified sexual or violent offence unless significant and exceptional circumstances apply.

Where an applicant is the subject of an outstanding charge or summons, their application may continue to be processed. However, depending on the circumstances, it is unlikely that a decision on the application will be made until the conclusion of the criminal proceedings.

During the duration of a licence, the licence holder must notify the council, in writing, within 48 hours, if they:

- receive any warnings, cautions or fixed penalties
- are arrested (regardless of whether they are charged with an offence)
- are charged with any criminal offence
- are convicted of any criminal offence
- allegations are made of their involvement in criminal activity

#### How information about you will be used

Harlow Council understands that your privacy is important to you. The information you provide on this form will be kept private and confidential and used for the purpose of processing your application.

However, Harlow Council is under a duty to protect the public funds it administers, and to this end may use the information provided for the prevention and detection of fraud. It may also share this information with other bodies responsible for auditing or administering public funds for these purposes. The Cabinet Office currently requires us to participate in a data matching exercise to assist in the prevention and detection of fraud. To process the application Harlow Council will share your information with Harlow Police so that checks can be carried out to check your suitability to hold a street trading licence and with teams within Harlow Council as part of the consultation process as outlined within the street trading policy.
